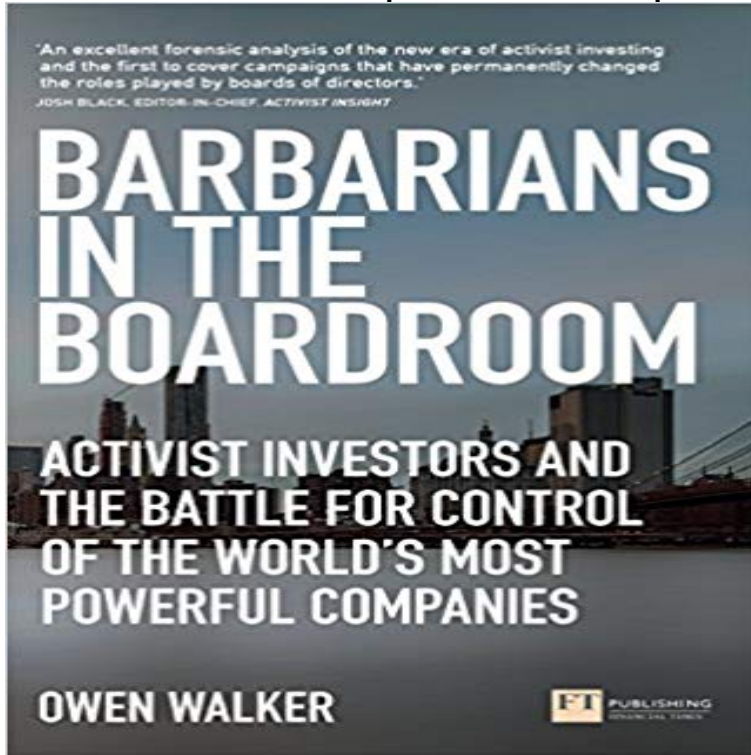


Barbarians in the Boardroom: Activist Investors and the battle for control of the worlds most powerful companies (Financial Times Series)



Activist investors have sent shockwaves through corporations in recent years, personally targeting directors and executives at some of the worlds largest companies.
