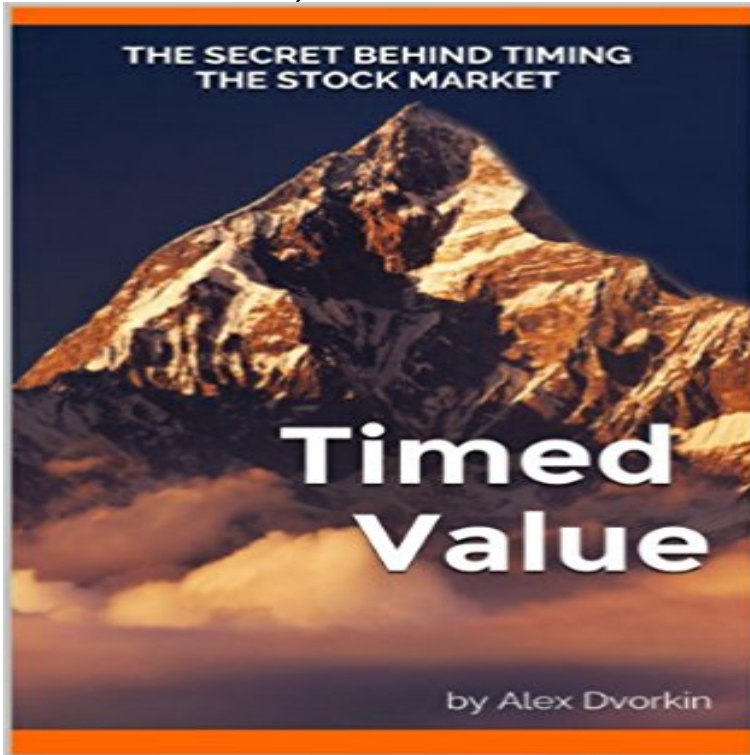


Timed Value: The Secret Behind Timing The Stock Market (Timed Profits Book 1)
