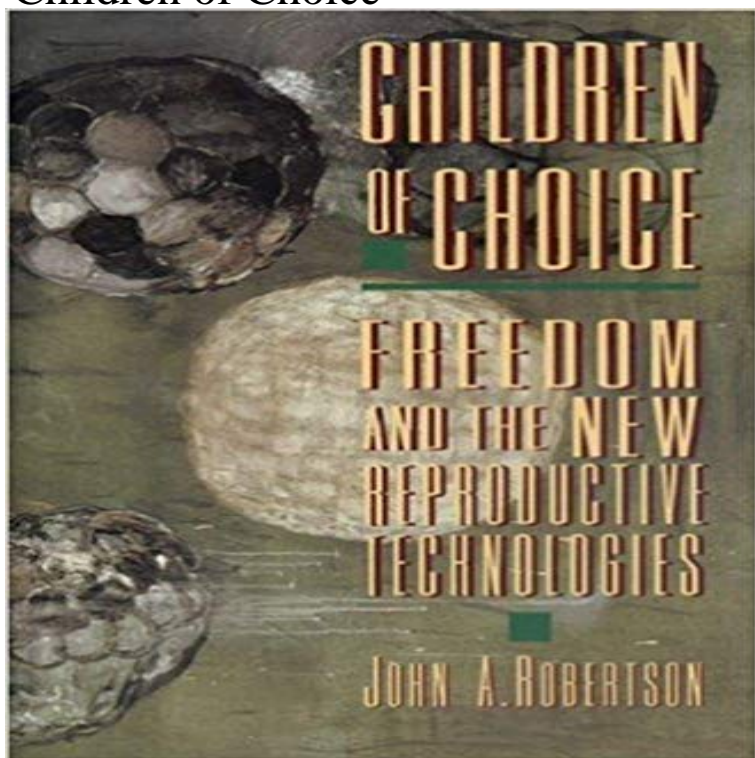


Children of Choice
