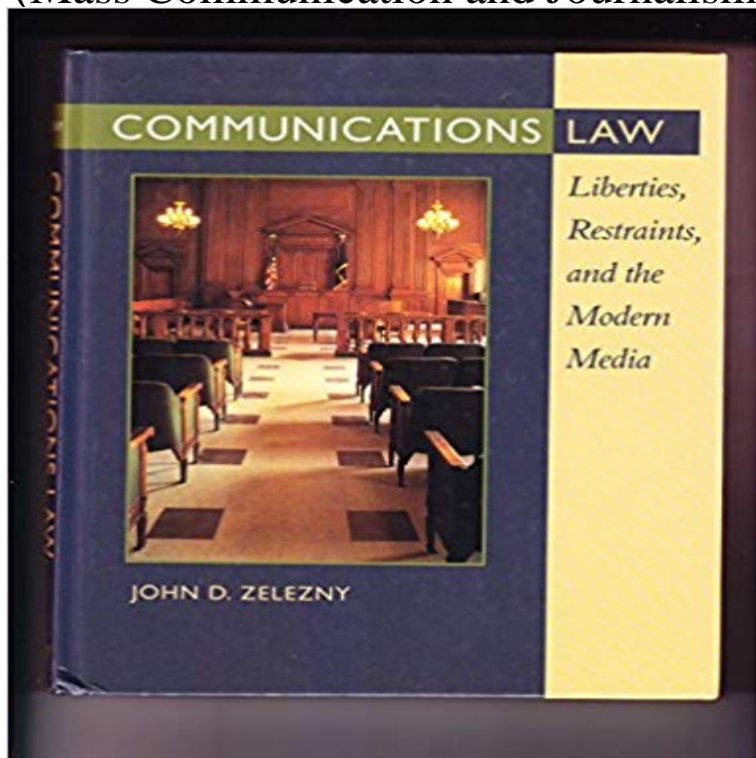


## Communications Law: Liberties, Restraints, and the Modern Media (Mass Communication and Journalism)
