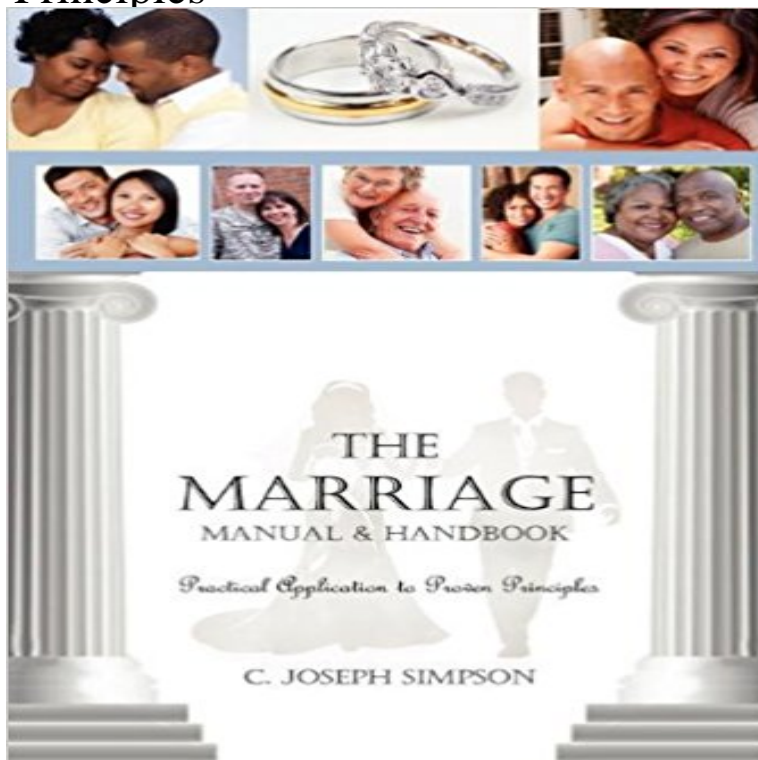


# The Marriage Manual & Handbook: Practical Application to Proven Principles
