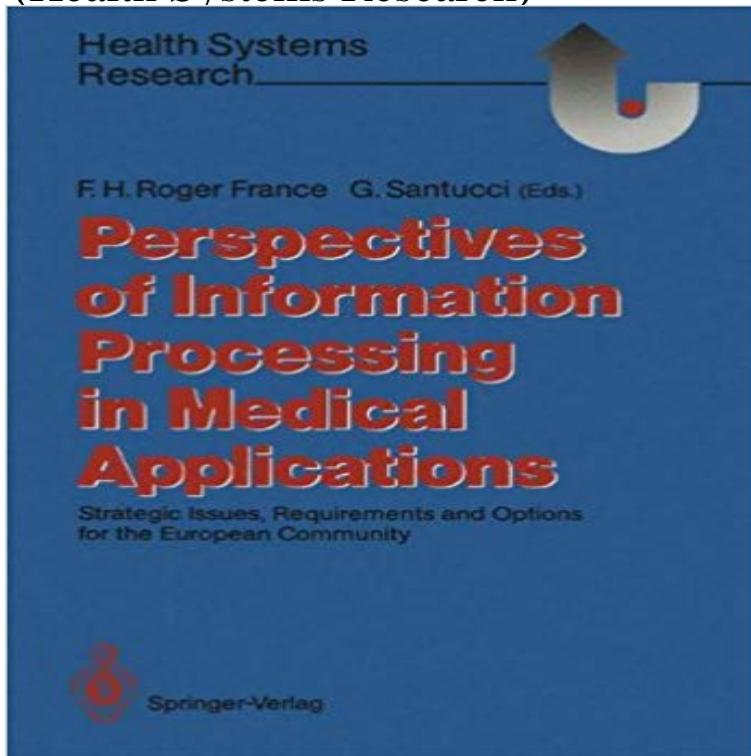


Perspectives of Information Processing in Medical Applications: Strategic Issues, Requirements and Options for the European Community (Health Systems Research)
