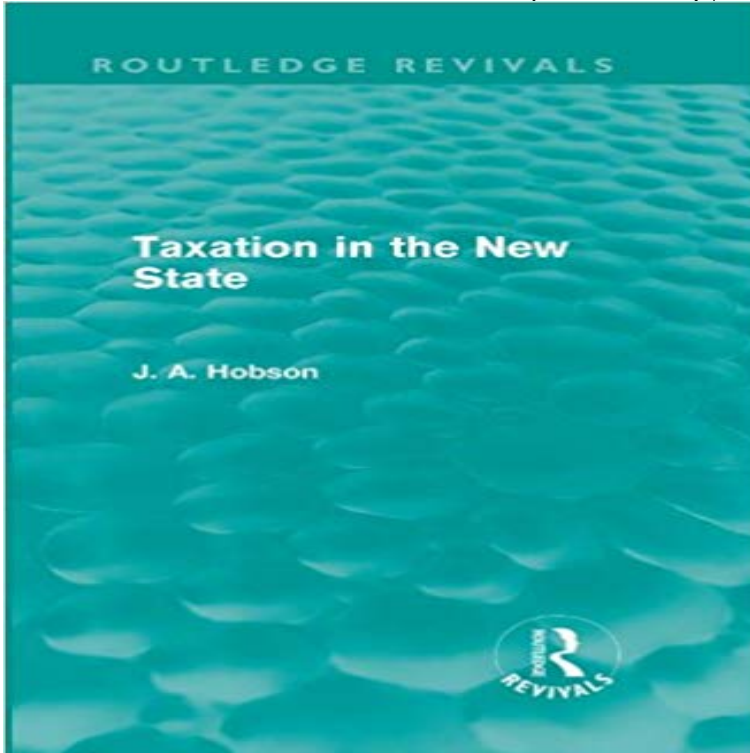


## Taxation in the New State (Routledge Revivals)
