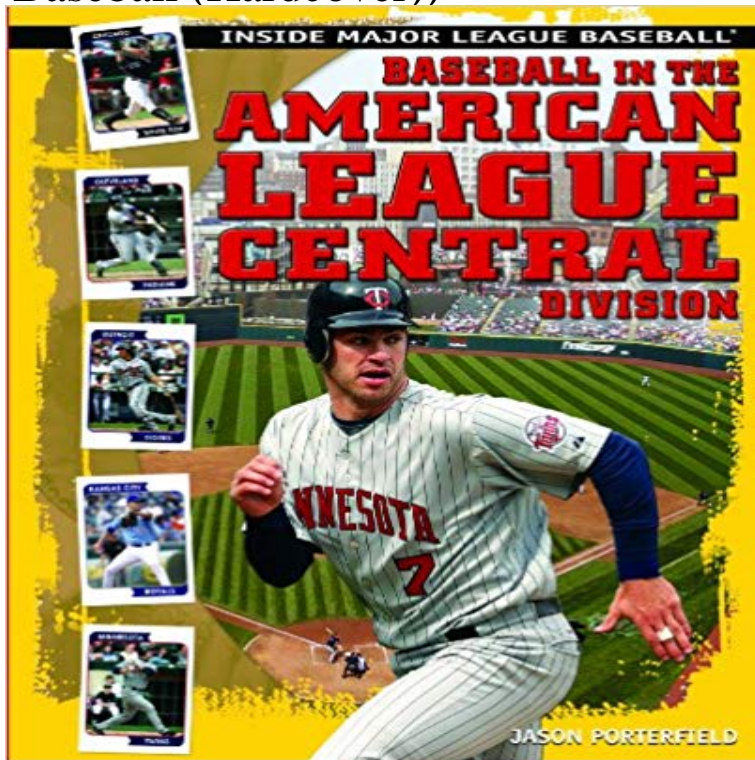


## Baseball in the American League Central Division (Inside Major League Baseball (Hardcover))
